## **ORDINANCE NO. 05-15**

AN ORDINANCE OF THE CITY OF BUCKLEY, WASHINGTON, AMENDING CHAPTER 10.04 OF THE BUCKLEY MUNICIPAL CODE TO INCORPORATE REFERENCE TO RCW 9.61.260 REGARDING CYBERSTALKING; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, pursuant to RCW 35A.12.140 the City may by reference adopt Washington State statutes; and

WHEREAS, Title 10 of the Buckley Municipal Code "Peace, Safety & Morals" encompasses many such references to state law; and

WHEREAS, the Buckley Municipal Code does not currently reference state law, RCW 9.61.260, concerning the crime of Cyberstalking; and

WHEREAS, currently any charges for Cyberstalking are being sent to Pierce County District Court for charging; and

WHEREAS, referencing RCW 9.61.260 in the Buckley Municipal Code would allow the crime of Cyberstalking to be charged into the Buckley Municipal Court; and

WHEREAS, as authorized by RCW 35A.12.140 the City Council desires to amend BMC 10.04.030 to add RCW 9.61.260 to the list of RCW Title 9 sections adopted by reference as they now exist and as hereinafter amended;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BUCKLEY, WASHINGTON DO ORDAIN AS FOLLOWS:

<u>Section 1.</u> <u>Amended.</u> Section 10.04.030 of the Buckley Municipal Code is hereby amended as follows:

## 10.04.030 RCW Title 2 sections adopted by reference.

Pursuant to the authority granted in RCW <u>35A.12.140</u>, the following sections of RCW Title <u>9</u> as set forth in Schedule B are adopted by reference as they now exist and as hereinafter amended:

<u>Section 2.</u> <u>Severability.</u> If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

<u>Section 3.</u> <u>Effective date.</u> This ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the city, and shall take effect and be in full force five (5) days after publication.
