**CITY COUNCIL
STUDY SESSION
February 6, 2024**

ATTENDEES: Council members Bergerson, Arsanto, Bender, Smith, Burbank and Green.

Also in attendance were Mayor Burkett, City Administrator Brunell, Finance Director Hines, Parks and Recreation Director Snodgrass, Police Records Clerk Burkett, Public Works Director Banks, Fire Chief Skogen, Asst. Fire Chief Olsen and Deputy City Clerk Clark.

Mayor Pro Tem Smith called the regularly scheduled meeting to order at 6:00 PM.

Council Committee Discussion:

Council discussed what committees would work for them and who would chair each committee.

- Community Services Chair: Green
- Admin/Finance Chair: Smith
- Transportation and Utilities Chair: Arsanto
- Parks and Recreation Chair: Anderson

Fire Department Update:

Chief Skogen spoke to Council updating them that the City of Buckley Fire Department has faced their busiest year on record, with 1530 calls for service. This represents a 9.5% increase compared to 2022. Emergency Medical Services make up the bulk of the call-volume at 75% of total runs. The current average is five calls per day for 2024, which may not sound like a lot, however most of these calls are EMS related. If each EMS call results in an ambulance transport, it is an average of two hours from time of dispatch until the crew is back in the station.

City of Buckley also services Wilkeson, Carbonado, Greenwater and Crystal Mt. resort. East Pierce will not be dispatched to Crystal Mt. any longer in a few months. Chief Skogen told Council that this is a necessity right now and is an emergency due to the rising call volume, high turnover, and losing three live-in volunteers. Mr. Skogen wanted to remind Council and public that the EMS levy lid lift will be on the November ballot. Buckley Fire Department has the full support of the Council to hopefully add two Full-time Firefighters.

Taxes, Rates, and Fees Updates:

City Administrator Brunell spoke to Council and discussed the additional changes to Taxes, Rates and Fees and that the 2024 fee schedule that her and City Clerk Percival updated is more streamlined and transparent. Staff will bring forward a resolution to Council.

PROS Plan:

Parks and Recreation Director Snodgrass presented Council the final draft of the 2024 PROS Plan and that in the summer of 2023 they began updating the Parks, Recreation and Open Space Plan. The City's previous plan, adopted in 2015 had expired and makes the City ineligible for some grant programs. Working with the direction of Council to bring forth a full and complete PROS Plan, Ms. Snodgrass stated that this will put the City in a competitive position for future grants.

Next Steps are:

- Adoption of the PROS Plan
- Submit PROS Plan to RCO to be eligible for grant programs – After Council adoption

- Apply for grant funds for Miller Park development – Spring 2024
- Use PROS plan as a guide for the Parks and Recreation element of the Comprehensive Plan

With nothing further, the Study Session was adjourned at 7:13 PM.

SUBJECT: Sidewalk and ADA Transition Plan

Purpose: The purpose of the Sidewalk and ADA Transition Plan is to ensure that the City of Buckley creates reasonable, accessible paths of travel in the public right of way for everyone, including people with disabilities. The City of Buckley is committed to making a significant and long-term commitment to improving the accessibility of its pedestrian facilities. The Sidewalk and ADA transition Plan will identify physical barriers and prioritize improvements that should be made throughout the City of Buckley.

The Engineering Proposal for the Sidewalk and ADA Transition Plan is not included in the 2024 City Budget. If the City Council approves this proposal the plan will be funded by Fund 102 Street Capital.

Next Steps: City Engineer will prepare the City Sidewalk and ADA Transition Plan. This plan will include the following items:

1. Inventory existing pedestrian facilities City-wide, using the City AutoCAD basemaps and available aerial and street view information. The inventory is to include a complete sidewalk system, including curb ramps, crosswalks, and driveways.
2. Prepare color coded maps of inventoried barriers and sub-standard pedestrian facilities, including missing sidewalk segments, and ADA barriers at intersections (both ramps and crosswalks) and driveways.
3. Identify policies and implementation of the plan and parameters for prioritization of projects.
4. Prepare a capital improvement plan (CIP) with prioritized list of projects, planned year of construction, estimated project costs, and probably funding source. Prepare City map of CIP projects.
5. Prepare a Draft Plan document for staff review and comment.
6. Present Final Plan document to City Committee and/or City Council.
7. Include identified projects in the city's 6-Year Street Transportation Improvement Plan (STIP).

Please find below our scope of work and fee estimate for providing engineering services to prepare the City Sidewalk and ADA Transition Plan.

The purpose of the planning document is to ensure that the City creates reasonable, accessible paths of travel in the public right-of-way for everyone, including people with disabilities. The City has roughly 200 street intersections and 260 street segments within its limits.

Please find below a description of our Scope of Work and Fee Estimate for engineering services:

SCOPE OF WORK

The following items of work are proposed to be completed:

1. Inventory existing pedestrian facilities City-wide, using the City AutoCAD basemaps and available aerial and street view information. Inventory to include complete sidewalk system, including curb ramps, crosswalks and driveways.
2. Prepare color coded maps of inventoried barriers and sub-standard pedestrian facilities, including missing sidewalk segments, and ADA barriers at intersections (both ramps and crosswalks) and driveways.
3. Develop project list to combine sidewalk segments and intersections into cost-effective schedules of work to address identified deficiencies. Prepare project cost estimates for projects to include engineering design, construction contingency, and construction management.
4. Identify policies for implementation of the plan and parameters for prioritization of projects.

5. Prepare capital improvement plan (CIP) with prioritized list of projects, planned year of construction, estimated project cost, and probably funding source. Prepare City map of CIP projects.

Re: 1st Quarter 2024 Activity Report

The City of Buckley Fire Department wrapped up the 1st Quarter of 2024 with 394 calls for service. This represents a 5% increase in calls for service over the same period of time last year.

Emergency Medical Services continues to make up the bulk of our call-volume at over 75% of total runs.

Our Annual Recruit Fire Academy kicked off on January 4th and is comprised of 12 Recruits from the City of Buckley Fire Department and 8 Recruits from Riverside Fire & Rescue. Upon completion of their Recruit Training on June 1st, the Recruits will have completed over 250 hours of training and certification to national standards. Training is held every Monday and Thursday night from 6-10PM and every other Saturday from 8AM-6PM. We are thankful for the ongoing dedication and support of our Volunteer and Paid staff for instructing and assisting with Recruit Academy. It is a tremendous time commitment that is in addition to members meeting their own ongoing training and shift requirements.



In addition to training and responding to calls for service, a number of personnel volunteered their time to take part in other events. These included "Read Across America" at Elk Ridge Elementary School and station tours for over 40 Pre-School students in the month of March.


Seven Firefighters participated in the Leukemia and Lymphoma Society Firefighters Stairclimb for the 20th consecutive year on March 10th at the Columbia Center in Seattle. In 2025 we look forward to reclaiming our once coveted title as one of the top fundraising teams for this worthwhile charity.




The Department continues to collaborate with our surrounding partner agencies to identify sustainable and cost-effective Paramedic Ambulance Service. A formal Request for Proposal is expected to be published in the coming weeks, among options for Council to consider with the Fire Department assuming all or part of Paramedic Ambulance Service.

Chief Skogen and City Administrator Brunell recently met with Pierce County Councilmember Dave Morell to justify a request for additional funding through the Payment in Lieu of Taxes (PILT) program. Counties receive an annual allocation of PILT funds from the US Department of the Interior that are intended to be distributed to local governments who provide their services to federal lands that otherwise do not pay taxes.

It is estimated that there are over 200 square miles of federal land within our current EMS service area that stretches to Mount Rainier National Park and the summit of Chinook Pass.



Broad Classifications



PATROL ACTIVITY

January 2024 01/01/2024, Trifecta of DUI Arrests - Officers rang in the New Year by stopping and arresting three DUI drivers> One of three arrested was a repeat offender amongst other criminal traffic violations so they earned a free night in the Enumclaw Jail. The other two received criminal citations and a summons to the Buckley Municipal Court.

01/10/2024, 2:01pm Disorderly Subject 29401 SR 410 - Officers were dispatched to an unwanted person at a local restaurant. A 46-year-old female was intoxicated and disorderly. Employees asked the female to leave the premises multiple times. When officers arrived, they contacted the 46-year-old who appeared very intoxicated. The female refused to follow the officer's commands and began cursing. Medical aid was requested for an evaluation. The female was transported to the hospital and cited for disorderly conduct.

01/13/2024, Assist Fire with a female in child labor - Assist Fire with a female reported to be giving birth to twins at the Econo Lodge. Officers assisted with transporting her three other children to the hospital. On the way to the hospital, officers made sure that the other kiddos received some food. The hospital would not allow the children to be at the hospital, so I returned them to the Econo Lodge. Officers further assisted the family with paying for an additional night at the Econo Lodge. Officers were reimbursed by the Buckley Law Enforcement Association.

January 2024 cont. 01/14/2024 - Death Investigation 200 blk Oferrell Dr. Carbonado - 47-year-old male was found deceased by a family member in the barn behind the house. He was last seen alive 10 days prior. Drug paraphernalia and a lighter were found near the deceased when he was discovered. The medical examiner took custody of his body. Investigation continues until M.E. report is complete.

01/21/2024, 12:41pm Trespass 29405 State Route 410 - Officers were dispatched to an unwanted person at the hotel. Employees advised of a 30-year-old male who was disrupting guests and being a nuisance. Employees wanted the male subject trespassed. The male was served a trespass letter and removed from the premises.

Possession of Stolen Property @ 15706 SE 376th ST Auburn (Muckleshoot Res). Officers were dispatched to take a report of a motor vehicle theft. A 23-year-old male reported his 2002 Chevrolet Silverado pickup truck was just stolen. A few days later, officers gained some information and searched for the stolen truck on 01/28/2024 in unincorporated Enumclaw. Officers located the stolen truck and a 33-year-old male suspect. The male tried to flee and started running through a field. Officers were on foot and pursued the male. Officers caught up to the suspect and he refused to comply with commands. The suspect was reaching into his waistband. The suspect was tased and taken into custody. Officers located 67.5 fentanyl pills search incident to arrest. Officers also secured a firearm that was found on top of the truck.
