May 6, 2025**

ATTENDEES: Council members Smith, Green, Arsanto, Burbank, Anderson and Bergerson.

Also, in attendance were: Mayor Burkett, City Administrator Brunell, Finance Director Hines, Fire Chief Skogen, Public Services Director Banks, Senior Planner Farnsworth, Police Records Clerk Burkett, and Deputy Clerk Clark.

Mayor Pro Tem Smith called the regularly scheduled meeting to order at 6:00 PM.

Finance Software Update:

Finance Director Hines through research shared with Council that the software systems Springbrook and Tyler were the top two choices and staff agreed because of the ease and functionality that they offered. If Council would like, this can be brought to the next Council meeting to be approved.

Fire Department Update:

Fire Chief Skogen explained to Council that things have changed drastically in the last few years due to growth and call volumes. If Council were to approve for shift work, it can reduce call volumes by three minutes, which is substantial. Ideally and a goal to work for would be 3 full-time employees per shift. That would be enough to get two units out the door.

City Administrator Brunell added that we already have a higher call volume than neighboring East Pierce areas and they have four or five full-time firefighters each shift.

Council discussed options the City could have to obtain more full-time firefighters.

Comp Plan Amendment:

Senior Planner Farnsworth explained to Council on why these edits have come forward for the Comprehensive Plan and we are currently in the process of doing this to incorporate comments from the Department of Commerce.

The edits to the Comprehensive Plan include the following

1. Land use and planning tools to reduce and mitigate wildfire risk.
2. Accommodating growth for emergency housing.
3. Identifying areas that have a high risk of residential displacement.
4. Including a direct reference to the Racially Disparate Impact report in the Housing Element. (Report is attached in the packets)

Next steps will be to have a Public Hearing with City Council on May 27th and City Council adoption of the Comprehensive Plan Amendment on July 8th.

Logo Redesign:

Mayor Burkett spoke on the new logo design and has been working with a local graphic designer to explore a refreshed City logo. The revised logo is a simplified and more modern design that reflects Buckley today. Some key elements include adding the White River, a Sasquatch, and the elk head in the mountain.

City Administrator Brunell will look into the total cost for changing to the new logo.

The Council discussed the options, and all agreed with option "B". Council member Anderson would like to see the maroon and gold stay, to represent White River High School colors.

Speed Limit Review:

Mayor Burkett has requested that we study potential speed limit reductions on key roads leading into downtown Buckley. This has been brought up with the conflicts on "A" and Main St. Mayor Burkett explained to Council why this would be a wise idea.

Streets currently under consideration for a lower speed limit include:

- Main St. from Spruce St. to SR 410
- Spruce St. from Main St. to Jefferson Ave.
- Jefferson Ave. from SR 410 to A St.
- Park Ave. from SR 410 to N A St.
- A St. from Park Ave. to Spiketon Rd.

Council discussed options and gave opinions on this topic and to keep the roads safe. Council would like to get an estimate for speed bumps and signage to slow people down. Public Services Director Banks was there to answer Council's questions and concerns.

With nothing further, the Study Session was adjourned at 7:37 PM.

SYSTEM ACCESS AND USE AGREEMENT (SAA)

Between

PIERCE COUNTY (COUNTY)

And

CITY OF BUCKLEY POLICE DEPARTMENT (SUBSCRIBER AGENCY)

This System Access and Use Agreement ("Agreement") is made by and between the County and "AGENCY" ("Subscriber Agency") for access by Subscriber Agency's approved mobile and portable radios and associated approved equipment to the Single County-Wide Communication System ("SCWCS").

1. OVERVIEW

The SCWCS consists of, but is not limited to, the following Subsystems associated to the 700, 410 VHF, and UHF systems:

P25 Master Site	Microwave	Fiber
Networking	Radio Infrastructure	Recording
Key Management	Wireless Data	Spectrum Assets

2. RECITALS

- 2.1 Subscriber Agency desires to access the SCWCS for public safety, first responder, and public service communications, using its approved mobile and portable radios and associated approved equipment on a non-exclusive shared basis with County and other Subscribers of the SCWCS.
- 2.2 County desires to provide Subscriber Agency access to the SCWCS for such use under the terms and conditions provided herein.
- 2.3 Subscriber Agency agrees to compensate County for its share of access to and use of the SCWCS through payment of a Subscriber Agency Fee as provided herein.

3. AGREEMENT

In consideration of the mutual promises and covenants contained herein, to be kept, performed, and fulfilled by the Parties, and other good consideration, it is mutually agreed as follows:

4. COUNTY RESPONSIBILITIES

- 4.1 County represents that the SCWCS coverage reliability target area is designed to deliver a high Digital Audio Quality. COUNTY will maintain the SCWCS in accordance with current industry standards as established by manufacturer's certified design. Subscriber Agency acknowledges

that coverage will vary from location to location because COUNTY cannot guarantee one hundred percent (100%) coverage.

- 4.2 COUNTY will install, test, and maintain the SCWCS, perform COUNTY's System Administrator responsibilities, and will take reasonable steps to meet the Original Equipment Manufacturer design, maintenance and security requirements. COUNTY will operate and administer the SCWCS in compliance with applicable FCC Rules.
- 4.3 COUNTY will provide to Subscriber Agency notice of any SCWCS planned upgrades, maintenance or enhancements. As a part of this notice, COUNTY will advise Subscriber Agency of potential SCWCS outages or impacts that will affect Subscriber Agency's access to and use of the SCWCS.

5. SUBSCRIBER AGENCY RESPONSIBILITIES

- 5.1 Subscriber Agency acknowledges and agrees that its access to and use of the SCWCS is on a non-exclusive, shared basis with other Subscriber Agencies of the SCWCS, including County (collectively, "COUNTY Parties" or "COUNTY"). Subscriber Agency agrees that it will operate its equipment so as not to cause undue interference with any other Subscriber Agency of the SCWCS.
- 5.2 Subscriber Agency shall perform its own communications coverage study to ensure that it is fully aware of the coverage within its operational area. Therefore, Subscriber Agency accepts the SCWCS coverage "as is".
- 5.3 Subscriber Agency shall assume responsibility for all Subscriber Agency employees, contractors, subcontractors and agents having access to and use of the SCWCS.
- 5.4 Subscriber Agency agrees that its access to and use of the SCWCS shall at all times comply with the rules and regulations of Part 90 of the Federal Communication Commission Rules and Regulations for public safety, first responder, and public service Subscriber Agency communications, including but not limited to Part 90, Subpart R of the Rules of the FCC, 47 C.F.R. § 90.521, et seq.; Section 90.179 of the Rules of the FCC, 47 C.F.R. § 90.179 (shared use of radio stations); all other Rules of the FCC; all decisions and orders of the FCC applicable to the SCWCS and Subscriber Agency's access to and use thereof, including all FCC technical requirements applicable to its use of the system; and the Communications Act of 1934, as amended ("FCC Rules"). Subscriber Agency will immediately cease any operation that is contrary to the FCC Rules.
- 5.5 Subscriber Agency shall notify COUNTY of any FCC correspondence or inquiries on matters that relate to its access to or use of the SCWCS within five (5) business days of Subscriber Agency's receipt thereof.
- 5.6 Subscriber Agency shall notify the COUNTY Point of Contact individuals on Exhibit A, attached hereto and incorporated herein, within twenty-four (24) hours of any outages, malfunctions, errors or any other functional problems that impact Subscriber Agency's ability to communicate or operate its services using the SCWCS.
- 5.7 Subscriber Agency shall notify COUNTY Point of Contact individuals on Exhibit A within twenty-four (24) hours of the loss or theft of any subscriber units.

- 5.8 Subscriber Agency shall appoint and identify on Exhibit A a primary and secondary contact as the Subscriber Agency's Point of Contact individuals to serve as its liaison to COUNTY. These Point of Contact individuals shall be responsible for:
- (a) Authorizing template modifications;
 - (b) Providing fleet mapping data for record-keeping purposes;
 - (c) Providing after hour emergency telephone numbers; and
 - (d) Attending Customer Advisory Committee and other meetings necessary for the safe and efficient operation of SCWCS.
- 5.9 Subscriber Agency assumes all costs and responsibilities for providing Subscriber Agency subscriber units (portables, mobiles, base stations, and consolettes) that access the SCWCS. Subscriber Agency may only use subscriber equipment that is compatible with and does not impact the capability and daily operations of the SCWCS and has been approved by COUNTY.
- (a) Subscriber Agency is responsible for acquiring its own Subscriber equipment.
 - (b) Subscriber Agency is responsible for proper Preventive Maintenance ("PM") and repair of its equipment. Proper PM and repair will assure that Subscriber Agency's equipment is in optimal operating order and will not have an adverse impact on the use of the SCWCS by other Subscriber Agencies.

6. SUBSCRIBER FEE

- 6.1 Subscriber Agency's SCWCS fee for 2025, which is based on an annual per unit cost of \$1,247.76 shall be as follows ("Subscriber Fee"):

Subscriber Count	Annual System Access Fee
25	\$31,194.00

- 6.2 This annual fee shall be paid on or before September 30, 2025, without setoff or deduction, based on Subscriber counts from 2024.

7. DURATION, CANCELLATION & TERMINATION

- 7.1 The term of this Agreement shall be one (1) year, from January 1, 2025, through December 31, 2025. This Agreement may be terminated by COUNTY or Subscriber Agency with ninety (90) days advance written notice.
- 7.2 If this Agreement is terminated for any reason, COUNTY will provide reasonable assistance, to the extent requested by Subscriber Agency, to facilitate the transfer of services to another system or provider.

8. INTERRUPTION OF SERVICE; FORCE MAJEURE

- 8.1 Except as provided in this Section 8.1, COUNTY shall not be liable to Subscriber Agency or any other person for any loss or damage, regardless of cause. COUNTY does not assume and shall have no liability under this Agreement for failure to provide, or delay in providing, service due

directly or indirectly to causes beyond the control of COUNTY or its subcontractors, including but not limited to acts of God, governmental entities or public enemies, strikes or unusually severe weather conditions. In the event of any failure or delay attributable to the fault of COUNTY or its subcontractors, Subscriber Agency's sole remedy shall be limited to the pro rata portion of the Subscriber Fee during the time of such failure or delay. Notwithstanding any other provision contained in this Agreement, Subscriber Agency agrees that no pro rata reduction of the Subscriber Fee shall be made for a single failure or delay of forty-eight (48) hours or less.

9. LIMITATIONS OF LIABILITY; INDEMNIFICATION

- 9.1 In no event shall COUNTY's liability under, arising out of or relating to this Agreement exceed the amount paid by Subscribing Agency to COUNTY for access to and use of the SCWCS. In no event will COUNTY be liable for lost profits, loss of use, loss of data, cost of procurement of substitute services, or any other special, incidental, indirect or consequential damages, however caused, and on any theory of liability, whether for breach of contract, tort (including negligence and strict liability) or otherwise.
- 9.2 Subscriber Agency acknowledges that the radio service of this Agreement uses radio channels to transmit voice and data communications and that the service may not be completely private. COUNTY shall not be liable to Subscriber Agency for any claims, losses, damages or costs which may result from lack of privacy on the SCWCS.
- 9.3 Subscriber Agency agrees to indemnify and save COUNTY harmless against claims for libel, slander, infringement or copyright from the material, in any form, transmitted over the SCWCS by Subscriber Agency or those using Subscriber Agency's equipment; against claims for infringement of patents arising from combining or using apparatus or systems of the Subscriber Agency with the facilities of COUNTY or any carrier; and against all other claims arising out of any act or omission of Subscriber Agency in connection with the facilities or service provided by COUNTY.
- 9.4 The Parties to this Agreement verify that they and their customers accept responsibility for any property damage, injury or death, caused by the acts or omissions of their respective employees acting within the scope of their employment under this Agreement to the fullest extent permitted by law. Signatories shall not be held personally liable for financial or any other obligations, clauses, or responsibilities regarding the SCWCS or its affects.
- 9.5 Subscriber Agency agrees to release, defend, indemnify and hold harmless COUNTY, its officers and employees, to the full extent permitted by law from and against any and all claims, damages, liabilities and expenses, including legal and attorney's fees, of any nature arising directly or indirectly out of this Agreement, the SCWCS or the services provided by COUNTY under this Agreement, including without limitation, claims for personal injury or wrongful death.

10. NOTICES

- 10.1 All notices given under this Agreement, except for emergency service requests, shall be in writing. All notices must be sent to COUNTY and Subscriber Agency POC at the addresses provided in Exhibit A.

11. MISCELLANEOUS

- 11.1 **Modification:** COUNTY, upon ninety (90) days advance written notice to Subscriber Agency, may modify this Agreement. Terms in this Agreement that are specific to a Subscriber Agency may be modified by a written amendment signed by both Parties.
- 11.2 **Governing Law:** This Agreement shall be governed by, and construed in accordance with, the laws of the State of Washington.
- 11.3 **Change of Law:** Subscriber Agency recognizes that applicable FCC Rules and other statutes, laws, ordinances, rules and regulations may change from time to time and that, accordingly, COUNTY in its sole discretion has the right without liability to modify this Agreement to comply with any such changes.
- 11.4 **Assignment:** This Agreement is for the Subscriber Agency and may not be assigned in whole or in part by Subscriber Agency to any other person or entity, without COUNTY's prior express consent, which shall not be unreasonably withheld. COUNTY reserves the right to assign this Agreement or subcontract any of its obligations hereunder.

12. Optional Upgrades, Repair, Maintenance and Installation

- 12.1 Maintenance, repair, upgrade and installation of radio communications subscriber equipment, upon notice from Subscriber Agency, will be supported through the Pierce County Radio Shop.

Annual Report

October 2025

Mission Statement

The mission of the Buckley Youth Center (BYC) is to provide a place where all youth are welcome to be seen, heard, involved, and grow through connection to their peers, community and with caring adults.

What we do:

The Youth Center continues to offer a free, safe, and welcoming space for teens after school, with daily drop-in hours until 6 p.m. on school days. The program provides a consistent place for youth to connect, play games, do art, and participate in activities under staff supervision, all within a welcoming open-door environment. A hot filling snack is served daily, ensuring every participant has access to nutritious food after school. Once a month, the center hosts a special *Late Night Friday* event featuring extended hours and themed activities that draw strong attendance. On non-school weekdays the center is open for afternoon to early evening hours to provide connection and support to our youth. Our program focuses on providing free engaging programming, substance use prevention, and increasing access to a range of vital services.

Attendance and Participation

- **Total Visits:**
 - January to September 2025: 6728
 - 2024-2025 school year: 7473
 - 2025 school year so far: 1463 (as of 10/10/2025)
- **Unique Youth Served:**
 - January to September 2025: 540
 - 2024-2025 school year: 496
 - 2025 school year so far: 243 (as of 10/10/2025)
- **City vs. County Residency:**

This data helps us continue receiving direct funding support from Pierce County. During the 2023–2025 grant cycle, we were awarded \$116,000 through the Youth Violence Prevention program.

 - **44%** are City of Buckley Residents
 - **56%** Unincorporated Pierce County
- **Daily Averages:**
 - Average daily for 2024-25 School Year: 40.17 a day
 - Summer 2025: 19.75
- **Who Are the Participants?**
 - 75% are Middle School Aged
 - 40% Female 59% Male 1% Non-Binary/Prefer not to answer

- 176 youth self-reported they received free or reduced school lunch

Staffing and Support

- Two permanent part-time staff manage daily operations. (one - 30hr per week & one - 18hr per week).
- 15 hours per week of additional part-time, non-permanent, grant-funded staff help maintain safe adult-to-youth ratios.
- One mental health master's intern from *Satya Counseling* provides support and resources for youth.
- Three long-term, dedicated weekly volunteers assist with programs and mentorship.
- Supervised by the Parks and Recreation Director.

Partnerships

The Youth Center benefits from and works with a wide range of partners to help support our mission and improve access to information, nutrition, and opportunities.

- **Buckley Library**- Onsite programing and reading support.
- **Dave Morrel, District 1 County** Councilmember – Direct allocations that bring more funding to help support increased needs in staff hours do to high volume of participants.
- **Good Roots NW** – Budgeted allocation for food at the drop-in program.
- **Local Business** – Wallys, Scoops, & Big Foot donating to provide reward give-a-ways.
- **Mother 2 Many** – Weekly donations of chicken and other snack supplies.
- **Pierce County Environmental Educators** – Environmental education and gardening programing .
- **Pierce County Health Department** – Funding for specialty prevention programs and staffing costs.
- **Rebecca's Odd Fellows** – Donate food and other supplies on a regular basis to support operations.
- **Satya Counseling & Wellness** – Master's Level Counseling Intern onsite for group programing weekly.
- **Wear It For Barrett** - Helmet promotion, donations and education.

Funding and Resources Supports

- **Youth Violence Prevention**
 - 2023-2025 Cycle we received \$116,000 in allocations both directly through the grant program and through additional allocations from the county council.
- **Tacoma Pierce County Health Department**
 - Small grant programs ranging from \$5,000 to \$15,000 to support programming and substance use reduction and prevention programs.
- **White River Hometown Grants**
 - Support for the late-night program & Friendsgiving.

- **Donations**
 - We receive donations on a very regular basis from many partners to help keep our cupboards full and youth fed. Estimated value of food donations in 2025 currently exceeds \$5,000.

Looking Ahead: Upcoming Programs & Goals

- **Goals and Strategic Priorities**
 - Sustain high daily attendance.
 - Continuing partnerships for mental health and substance reduction programs.
 - Provide ongoing staff training to expand support and skills.
 - Diversify external funding streams.
 - Strengthening partnerships to create meaningful and engaging programming.
 - Maintain safe staffing ratios.
 - Stay open during high-risk hours.
 - Keep the surrounding park space teen-welcoming and safe.
- **Planned Special Programs:**
 - TPCHD Grant: Training for staff on Not On Tobacco Youth Cessation Facilitator Training. For weekly programming to support those youth struggling with substance use.
 - Friendsgiving: Annual thanksgiving dinner for the youth with all the fixings. Supported by our partners and the community.
 - Monthly Teen Late Nights: October – Harvest Party.
 - Party at the Park: Last day of school celebration.
- **Facility:**
 - Simple in-house fix to the rafters air flow improved the functionality of the HVAC system.
 - Stove was replaced in fall of 2024
 - Need for additional deep freezer
 - Flooring nearing end of life.

Summary & Closing:

The Buckley Youth Center continues to be a welcoming and important place for young people in our community. Every day we see the positive impact of providing a safe space where teens can relax, connect, and find support. The center's growth and success are a reflection of the care and commitment shared by our staff, volunteers, and community partners who all play a role in helping youth feel valued and supported. The program was built on a strong community foundation and a shared vision for recreation services that meet the unique needs of teens. That vision and support have shaped the Youth Center into what it is today.

With the continued support from City of Buckley leaders, Pierce County, the Tacoma-Pierce County Health Department, local businesses, and many community members, we can provide

meaningful programs that promote health, connection, and opportunity. Together, we are building a stronger foundation for our youth and for the future of Buckley.

As we look ahead, we remain committed to keeping the Youth Center a free and accessible place for all youth in the Buckley and White River Community.
