CITY OF BUCKLEY REFINANCES BONDS FOR INTEREST COST SAVINGS

In 2010, the City of Buckley issued voter-approved Unlimited Tax General Obligation Bonds for the purpose of constructing and equipping a new fire station. The City recently refinanced a portion of the 2010 Unlimited Tax General Obligation Bonds to achieve interest cost savings for the taxpayers.

As part of the process, the City's staff presented information to the national rating agency of Standard & Poors Global Ratings. According to City Administrator, Dave Schmidt, "The City was upgraded from AA- to AA. This is a significant achievement for the City and its taxpayers, and the second upgrade to our bond rating in four years. The higher the rating grade, then the lower the interest cost."

Mayor Johnson said "this rating grade of AA reflects that the City is very well-managed and has strong financial practices in place for the benefit of our citizens." Fire Chief Alan Predmore stated, "We timed the refinancing bond while interest rates are still low. We presented the idea to the City Council, and the Councilmembers were very supportive."

The City received the AA bond rating grade based on the key factors of: 1. Strong financial reserves; 2. Financial management practices and policies; 3. Strength of the economy; and 4. Experienced management in operating the City in an efficient manner.

As part of the rating process, City staff prepared for a presentation to S&P Global Ratings. The presentation team was comprised of: Dave Schmidt (City Administrator), Alan Predmore (Fire Chief), Sheila Bazzar (Finance Director), and Bond Underwriter Jim Nelson (of D.A. Davidson & Co). The team presented information and answered questions that dealt with the topics of management, finances, local economy and long-term planning.

The Unlimited Tax General Obligation Refunding Bonds achieved total interest cost savings of \$377,987 for the City's taxpayers. The average annual savings (over the remaining 23 years) are \$16,434. The City's goal was to achieve a Net Present Value savings percent greater than 5.00%. The City achieved a Net Present Value savings percentage of 7.12%.

The Unlimited Tax General Obligation Refunding Bonds were priced on December 5th in Seattle at the offices of D.A. Davidson & Co. The 23-year Refunding Bonds achieved a True Interest Cost percent of 3.07%.

ELLEN BOYD

Ellen Winifred (Colgan) Boyd, age 29, died on November 7, 2017--the result of a rare and aggressive form of ovarian cancer. Born in Hollywood, CA to Dennis Colgan and Deborah See-Colgan in May 1988, Ellen moved with her parents and younger brother to Enumclaw when she was 6 years old. She was a 2006 graduate of Enumclaw High School, a 2008 graduate of Green River Community College, and died just short of completing her undergraduate degree in Urban Studies at the University of Washington. Ellen worked as a life-guard at the Enumclaw Aquatic Center from the age of 15 to 20, advancing to lead guard. During high school, Ellen played water polo and was on the swim team, setting new time records with her relay team. In 2008, at age 20, she began working for the City of Buckley as facilitator of the newly opened Youth Activities Center, a position she held for 3 years until transferring into the position of Director of Recreation Services--work that ignited a passion for supporting both youth and senior citizens in her community.

She married the love of her life, Benjamin Boyd, in June 2009. Liam arrived to bless their lives in December 2013 and twins, Lucille and Elliott, were born in May 2015. Family, friends, a love for learning, and a desire to serve her community filled her heart and days with meaning. Although the amount of time given to Ellen was short, she used it well, touching the lives of many in a positive way. In addition to her husband and young children, step-daughter, Emily, parents and brother, Grady--Ellen is survived by her parents in-law, Bill and Ronda Boyd; grandparents, Bob and Marie Erikson; grandfather, Ronald Bariel; grandparents, Bill and Donna See of Nevada, IA; grandmother, Ruby Dolores See of Marshalltown, IA; and loving family members on both sides too numerous to mention.
