### **Project Description:**

The City of Buckley received a site plan review application (SPR-24-0002) for the construction of a new shell building and civil construction on the rest of the site in preparation of the construction of three additional buildings.

**Environmental Determination:** The City of Buckley has determined that this proposal does not have a probable significant adverse impact on the environment. If the City issues a revised determination, the City will open a new comment period.
