

**City Council  
January 24, 2023**

Mayor Burkett called the regularly scheduled meeting to order at 6:01 PM.

Upon roll call the following members were present: Smith, Rose, Burbank, Green (via Zoom), Arsanto, Sundstrom, and Anderson.

Also present were: City Administrator Brunell, Director of Parks & Recreation Snodgrass, Director of Public Works Banks, Police Chief Alfano, City Engineer Miller, Fire Chief Skogen, Senior Center Coordinator Mickelson, Finance Director Hines, and City Clerk Percival.

Mayor Burkett stated that there was an amended agenda and asked if there were any other additions, deletions, or changes to the agenda.

**Connie Bender** – Ms. Bender stated that she disagrees with this agreement. There is nothing informing people that they will be paying the Sundstroms, Perkins Prairie, and Sutter each for their latecomers agreements.

**Patrick McCleary** – Mr. McCleary stated that he purchased property on Sheets Rd. and doesn't understand why he would have to pay this when he would prefer to run a 6 or 8 inch line not a 2 inch line.

City Engineer Miller reviewed the Latecomers Agreement and explained it in detail.

**Marvin Sundstrom Jr.** – Mr. Sundstrom stated that if folks didn't want to hook up to the sewer line they could put in a septic.

**Upon no further public testimony, Mayor Burkett closed the Public Hearing and reconvened the City Council meeting at 7:25 PM.**

City Administrator Brunell gave a brief update on the 410 realignment project.


Director of Parks & Recreation Snodgrass shared information regarding the Senior Citizen Board Audit.


**CITIZEN PARTICIPATION**
