RESOLUTION NO. 21-03

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BUCKLEY, PIERCE COUNTY, WASHINGTON ESTABLISHING A SOLE SOURCE PROVIDER AND AUTHORIZING THE PURCHASE OF A NEW VAN FOR THE BUCKLEY KIWANIS FOOD BANK

WHEREAS, Washington law RCW 39.04.280 (1) (a) provides that competitive bid requirements may be waived by the governing body of a municipality for purchases that are clearly and legitimately limited to a single source of supply and RCW 39.04.280(1)(b) also authorizes waiver for “special facilities or market conditions”; and

WHEREAS, the City of Buckley has seen a significant increase in food security needs and regular transportation services to fulfill the hardships that several of our community members are facing due to the national pandemic of COVID-19; and

WHEREAS, the Food Bank currently uses an aging and insufficient pickup truck that is in need of replacement with a new van that will specifically address the volume and load requirements associated with the Food Banks use; and

WHEREAS, the City applied for a Greater Tacoma Community Foundation COVID-19 Emergency Response Fund grant specifically for a new transportation van quoted by Fugate Ford totaling \$51,170.00 that will meet the Buckley Kiwanis Food Bank distribution needs that have been elevated by COVID-19 and the economic situation within our community; and

WHEREAS, Fugate Ford has a passion and desire to better secure basic essentials in food security to vulnerable populations in our community and has lowered the price of the van to include additional safety features and a Platinum Warranty & Service Package to ensure specific repairs and maintenance are performed at no additional cost to the City; and


NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Buckley hereby declares:

Section 1. Based upon the preceding legislative findings, the City Council hereby declares that the purchase of 2020 Ford Cargo Van for the City of Buckley and use by the Buckley Kiwanis Food Bank is clearly and legitimately limited to the award terms and conditions as a sole source purchase of a specific van with Fugate Ford. The City Council declares that the unique opportunity provided qualifies as special market conditions pursuant to RCW 39.04.280(1)(a) and (b).


Section 2. Based upon the preceding legislative findings, and pursuant to RCW 39.04.280 (1) (a) and (b), the competitive bidding requirements for the City of Buckley are hereby waived and the City Administrator is authorized to purchase a 2020 Ford T350 Cargo Van in the amount of \$51,170.00 which includes Washington state sales tax.

Section 3. This Resolution shall take place immediately
