**RESOLUTION NO. 21-04**

**A RESOLUTION OF THE CITY OF BUCKLEY, WASHINGTON, DECLARING THE  
ADOPTION OF A WORK PLAN FOR THE 2024 PERIODIC UPDATE OF  
BUCKLEY'S COMPREHENSIVE PLAN**

WHEREAS, in compliance with RCW 36.70A the City of Buckley adopted its first Comprehensive Plan in 1995; and

WHEREAS, RCW 36.70A.130 provides that cities shall take action to continuously review and, if needed, revise their comprehensive plans and development regulations to ensure the plan and regulations comply with the requirements of that chapter; and

WHEREAS, in order to comply with RCW 36.70A.130, the City of Buckley completed the first required periodic update of its Comprehensive Plan in 2005 and the most recent update of its comprehensive plan in 2015; and

WHEREAS, Buckley's next required periodic Comprehensive Plan update must be completed by June 30, 2024; and

WHEREAS, comprehensive plan periodic updates require significant advance work and considerations including the establishment of new growth targets in coordination with other jurisdictions; a completed review and evaluation of Buckley's buildable lands in coordination with Pierce County; updates of all comprehensive plan elements; review for consistency with the Growth Management Act, Multi-County Planning Policies and Countywide Planning Policies; updates of city development regulations based on the Comprehensive Plan updates; and public participation throughout the periodic update process; and

WHEREAS, planning for the next comprehensive plan periodic update should begin a few years in advance of the periodic update deadline of June 30, 2024; particularly to ensure the public is able to participate early in the comprehensive plan update process; and

WHEREAS, while the Growth Management Act does not require a work plan for the development of the comprehensive plan update, such a work plan can help guide and foster a mutual understanding of the comprehensive plan update process background, steps, timeline, reviewing bodies, stakeholders and decision makers; and

WHEREAS, while the attached work plan includes initial ideas to guide public participation, a separate and more detailed public participation plan will be brought to Buckley City Council for adoption later in 2021 which will help ensure Buckley's Comprehensive Plan update process fosters robust, inclusive and equitable public participation; and

WHEREAS, the City of Buckley Planning Commission developed the attached Comprehensive Plan Update Work Plan and recommended its adoption at an open record public hearing held February 1, 2021; now, therefore,


**THE CITY COUNCIL OF THE CITY OF BUCKLEY HEREBY RESOLVES AS FOLLOWS:**
